

# Cheam School Fees Schedule 2025-26

Cheam has been required to charge and account for VAT on school fees from 1 January 2025. VAT treatment is based on current legislation, latest HMRC guidance and specialist tax advice. The School's VAT registration number is 478595619, which will be shown on all future invoices.
